

ACCREDITATION AGREEMENT

(Made under § 269, Section 2 of the Commercial Code No. 513/1991 Coll. as amended)

(Hereinafter the "Agreement")

BETWEEN

(Hereinafter the "Reporter")

In the following wording:

- 1) Based on the Reporter's request, delivered to the AGENCY company, the AGENCY company grants, by the Agreement, its consent to the Reporter to enter the below specified parts of an Automotodrom Slovakia Ring areas in Orechová Potôň (hereinafter the "Autodrome"), during the parts, accessible to the public, of an event: "Prix of Slovak Republic Motorcycle Circuit Championship 2011", which will take place from 17 - 19 June 2011 (hereinafter the "Event").
2) The Reporter is entitled, during his presence in the Autodrome area under the Agreement, (i) to watch the Event (ii) from places marked AGENCY as "places accessible for taking pictures", to personally make the visual and audio-visual records capturing the progress of the races of the Event and parts of the Autodrome (hereinafter the "Records"), (iii) to make use of eventual "shuttle service" operated by the AGENCY and (iv) to stay and monitor current results in a room designated by the AGENCY for the media representatives (a media center). The Reporter undertakes to refrain, in the Autodrome area, from any commercial and/or advertising activity.
3) In case the Reporter was given an Accreditation Pass with a MEDIA marking, the Reporter is entitled to enter the following parts of the Autodrome Area: paddock, media center, terrace next to the media center; in case the Reporter was given an Accreditation Pass with a MEDIA and TRACK marking, the Reporter is also entitled to enter: a box alley, places accessible for taking pictures, speed track (however, always so that there are steel crash barriers between the Reporter and the speed track) and a start grid (the specification and definition of terms according to this sentence are included in Appendix No. 1 to the Agreement - Definition of Terms). The service communications around the track can be entered only with appropriate photo-vest (hereinafter the "Selected Parts of the Autodrome"). It is strictly prohibited for the Reporter to enter other parts of the Autodrome area. The Reporter is also obligated to immediately leave the Selected Parts of the Autodrome if he is instructed to do so by the AGENCY company, persons authorized by the AGENCY (including flag marshals, the security service staff, the rescue service staff, the quick technical aid staff).
4) In order for the Reporter to enter the Selected Parts of the Autodrome and to use the "shuttle service" during the Event, the AGENCY will give the Reporter a document proving the Reporter's authorization to enter the Selected Parts of the Autodrome area and to make use of the "shuttle service" (hereinafter the "Accreditation Pass"). The Accreditation Pass is not transferable. The Reporter will be entitled to enter the Selected Parts of the Autodrome and to make use of the "shuttle service" exclusively in case, when he submits, at the time of entering the Autodrome area and the check points for individual services, his valid Accreditation Pass (not damaged or dirty to such extent that it makes it impossible or makes it significantly difficult to identify the Accreditation Pass and/or its authorized holder) and his ID. If he fails to submit the documents according to the previous sentence, the AGENCY is not obligated to make accessible for the Reporter the Selected Parts of the Autodrome or to provide him with the above services, without the Reporter being entitled to any compensation and/or indemnification. The Reporter is obligated to immediately inform the AGENCY on the loss of the Accreditation Pass and/or the theft of it and/or damage and/or defilement to such extent that it makes it impossible or makes it significantly difficult to identify the Accreditation Pass and/or its authorized holder. The Reporter is liable to the AGENCY for damages originated due to the failure to fulfill the duties according to the previous sentence of this paragraph.

By signing the Agreement, the Reporter confirms that the AGENCY gave him the Accreditation Pass with the following marking (mark only one option with a cross):

Table with 2 rows and 2 columns. Row 1: Checkbox for MEDIA, followed by signature lines for AGENCY and Reporter. Row 2: Checkbox for MEDIA and TRACK, followed by signature lines for AGENCY and Reporter.

- 5) The Reporter is entitled to use the Records only for informational purposes, exclusively in the Medium identified in the heading of the Agreement, while the Reporter undertakes to provide for the publishing, in the Medium, (in accordance with the below requirements) of at least one expanded report of the Event in connection with at least one photographic Record of the Event. The Reporter is obligated to deliver a published report and/or Record to the AGENCY within 5 days of publishing. The failure to meet the obligation according to the previous two sentences may result in the rejection to grant accreditation to the Reporter for future events. The Reporter undertakes, during the making and subsequent use of the Records made, to comply with applicable and effective legislation of the Slovak Republic, i.e. including the provisions of Act No. 40/1964 Coll. the Civil Code, related to the protection of personality; the Reporter is obligated, if necessary, to acquire consent of persons (legal and physical) affected by the Records. He is obligated to do so himself at his expense. The Reporter undertakes not to use or not to make possible to use any Record for commercial purposes without the AGENCY's special prior written consent to use a specific Record for specific purposes. The Reporter undertakes to make sure that the Records will not be disseminated, displayed, made accessible, published and used otherwise than by being published in the Medium. The Reporter undertakes to make sure that information and data published in the Medium in relation to the Event about the Autodrome and/or AGENCY will (in any respect) be positive and will be approved by the AGENCY company in advance. Further, the Reporter undertakes to make sure that no Record will ever be used together and/or in connection (neither as an illustration/animation picture accompanying a text and/or spoken word) with information, opinions, comments and other data (expressed in a printed and/or electronic and/or broadcast form) that could lead to the danger of a harm to the good name (goodwill, reputation) of the Autodrome, the AGENCY or SLOVAKIA RING s.r.o., 800 Orechová Potôň, Reg. No.: 44 154 992 and/or will be able to harm the good name (goodwill, reputation) of the Autodrome, the AGENCY or SLOVAKIA RING s.r.o., and/or will be able to cause any harm to the Autodrome, the AGENCY or SLOVAKIA RING s.r.o. regardless whether such data are true or not.
- 6) The Reporter participates in the Event and enters the Autodrome area (including the Selected Parts of the Autodrome) at his own risk. The Reporter confirms that he fully assumes liability for any damage and harm caused by him during his presence in the Autodrome area. The Reporter declares that he will take any necessary measures to minimize the threat of injury of his person or persons around him, and also persons moving on the Autodrome speed track, and will adhere to the instructions of authorized persons of the AGENCY. The Reporter confirms that the AGENCY informed him on possible dangers connected with the motorcycle sport, on the character of the track used for the racing, including the security and other risks and threats related to its use. The Reporter confirms that he is aware of an increased risk of accidents next to the speed track and the box alley. The Reporter undertakes to take care of the things brought in and placed in the Autodrome area himself and at his expense.
- 7) The Reporter undertakes to respect any instructions and regulations of the AGENCY company and the AGENCY's authorized persons (including the flag marshals, the security service staff, the rescue service staff, the quick technical aid staff), including the safety regulations, the flag and light signalization, etc. The Reporter further undertakes to respect the AGENCY's Operating Rules, duties arising for participants, visitors and/or spectators of the Event from a document called Special Provisions of the Event, and also duties arising for participants and/or spectators of the Event from a document called ALPE ADRIA – CPM RULES 2011. By signing the Agreement, the Reporter confirms that before signing the Agreement he read and acquainted himself with the AGENCY's Operating Rules, Special Provisions of the Event and also with the ALPE ADRIA – CPM RULES 2011 document.
- 8) The contracting parties have agreed that the AGENCY is entitled to anytime expel the Reporter from the Autodrome area (also without stating a reason) and to take away from him the Accreditation Pass, without the Reporter being entitled to any compensation and/or indemnification
- 9) The Reporter is aware of and agrees with the fact that his entering the Autodrome area (and also the Selected Parts of the Autodrome) can be conditioned by a duty to prove his identity and/or to prove his authorization to enter the area and/or by the inspection of things that the Reporter brings in or takes out from the Autodrome area carried out by the AGENCY company and/or by a third person authorized by it. The Reporter is aware of the fact that the Autodrome area can be continuously monitored by means of a video record of an audio record (a camera system). The Reporter agrees with the making of the video record or the audio record according to the previous sentence. The Reporter agrees with the use of the given records for the purposes of any court, criminal, administrative or other proceedings (also as a piece of evidence), and also other proceedings conducted by the state administration bodies and the public authorities.
- 10) The Reporter hereby grants his consent to the AGENCY company to process his name, surname, date of birth, permanent address and e-mail address and the Medium identification in order (a) to keep records of the media representatives at the Event, (b) to include him into a database (information system) administered by the AGENCY, (c) to render services and to carry out transactions by the AGENCY company (d) to prepare internal analyses and statistics of the AGENCY company (e) to contact (provision of information), to warn of and/or to announce events and/or services rendered by the AGENCY company, also in the form of delivering documents to the above contact information (f) to use the above data by the AGENCY company for marketing purposes and for giving them to third parties, which will cooperate with the AGENCY during the organization of an event and which will be entrusted by the AGENCY with marketing activity in its favor, and also (g) for purposes defined by generally binding legal regulations and also for the purposes of archiving this declaration. Under this paragraph the Reporter grants his consent for a period of 10 years of the signing of the Agreement. The Reporter can withdraw his consent with the processing of data in writing by delivering a written withdrawal from consent to the AGENCY company.
- 11) The Agreement goes into effect on the day of its signing by both contracting parties. The Agreement is made in two counterparts with validity of the original, of which one is for the Reporter and one for the AGENCY. The Agreement and also the rights and duties originated under the Agreement or all of its Appendices are governed by Slovak law and the settlement of disputes related to legal relations related to, based on or originated under the Agreement is subject to the jurisdiction of Slovak courts.
